7.13 subdivision 6. The commissioner's salary must be established according to the procedure
7.14 in section 15A.0815, subdivision 5, in the same range as specified for the commissioner of
7.15 management and budget.

7.16 Subd. 2. **Duties of the commissioner.** (a) The commissioner may apply for and accept
7.17 on behalf of the state any grants, bequests, gifts, or contributions for the purpose of carrying
