1.3 "ARTICLE 1

1.4 TEMPORARY POSTRETIREMENT ADJUSTMENTS

1.5 Section 1. TEMPORARY POSTRETIREMENT ADJUSTMENTS.

1.6 On January 31, 2023, and January 31, 2024, each pension plan that is a covered retirement  
1.7 plan listed in subdivision 2 of Minnesota Statutes, section 356.32, the judges retirement  
1.8 plan, and the unclassified employees retirement plan must pay to each individual who is  
1.9 receiving an annuity from the plan a lump sum payment equal to 2.5 percent of the annual  
1.10 amount received by the individual for the prior calendar year. If the lump sum payment is  
1.11 an eligible rollover distribution as defined in Minnesota Statutes, section 356.635,  
1.12 subdivisions 4 and 5, the plan must permit the individual to elect a direct rollover, as provided  
1.13 under Minnesota Statutes, section 356.635, subdivisions 3 to 7.

1.14 EFFECTIVE DATE. This section is effective the day following final enactment.

2.17 (b) The actuarial valuation for each of the covered retirement plans listed in section  
 2.18 356.415, subdivision 2, and the St. Paul Teachers Retirement Fund Association must take  
 2.19 into account the postretirement adjustment rate or rates applicable to the plan as specified  
 2.20 in section 354A.29, subdivision 7, or 356.415, whichever applies.

2.21 (c) The actuarial valuation must use the applicable salary increase and payroll growth  
 2.22 assumptions found in the appendix to the standards for actuarial work adopted by the  
 2.23 Legislative Commission on Pensions and Retirement pursuant to section 3.85, subdivision  
 2.24 10. The appendix must be updated whenever new assumptions have been approved or  
 2.25 deemed approved under subdivision 18.

2.26 (d) The assumptions set forth in the appendix to the standards for actuarial work continue  
 2.27 to apply, unless a different salary assumption or a different payroll increase assumption:

2.28 (1) has been proposed by the governing board of the applicable retirement plan;

2.29 (2) is accompanied by the concurring recommendation of the actuary retained under  
 2.30 section 356.214, subdivision 1, if applicable, or by the approved actuary preparing the most  
 2.31 recent actuarial valuation report if section 356.214 does not apply; and

2.32 (3) has been approved or deemed approved under subdivision 18.

3.4 Subd. 3b. **Direct state aid.** (a) ~~The state shall pay \$4,500,000 on October 1, 2018, and~~  
3.5 ~~October 1, 2019, to the public employees police and fire retirement plan.~~ By October 1 of  
3.6 each year ~~after 2019~~, the state shall pay ~~\$9,000,000~~ \$13,500,000 to the public employees

3.19 (b) In addition to other amounts specified in this subdivision, the state shall pay  
3.20 \$7,000,000 as state aid to the St. Paul Teachers Retirement Fund Association.

3.21 (c) In addition to the amounts specified in paragraphs (a) and (b), the state shall pay  
3.22 ~~\$5,000,000~~ \$7,500,000 as state aid to the St. Paul Teachers Retirement Fund Association.

3.23 (d) The aid under this subdivision is payable October 1 annually. The commissioner of

 4.15 appropriated from the general fund to the judges' retirement fund.

4.16 (b) The aid under paragraph (a) continues until the earlier of:

4.17 (1) the first day of the fiscal year following the fiscal year in which the actuarial value  
 4.18 of assets of the fund equals or exceeds 100 percent of the actuarial accrued liabilities as  
 4.19 reported by the actuary retained under section 356.214 in the annual actuarial valuation

### 4.25 **APPROPRIATION**

4.26 Section 1. **APPROPRIATION.**

4.27 (a) \$370,000,000 in fiscal year 2023 is appropriated from the general fund to the pension  
 4.28 plans specified in paragraph (b), to be allocated by the commissioner of management and  
 4.29 budget among the pension plans in the same ratio that the market value of assets as of the

5.1 most recent June 30 for each pension plan bears to the sum of the market value of assets  
5.2 for all specified pension plans as of the most recent June 30.

5.3 (b) The amount appropriated under paragraph (a) shall be allocated among the following  
5.4 pension plans:

5.5 (1) the general state employees retirement plan of the Minnesota State Retirement System;

5.6 (2) the general employees retirement plan of the Public Employees Retirement  
5.7 Association;

5.8 (3) the Teachers Retirement Association;

5.9 (4) the St. Paul Teachers Retirement Fund Association;

5.10 (5) the State Patrol retirement plan;

5.11 (6) the public employees police and fire plan of the Public Employees Retirement  
5.12 Association;

5.13 (7) the correctional state employees retirement plan of the Minnesota State Retirement  
5.14 System;

5.15 (8) the local government correctional service retirement plan of the Public Employees  
5.16 Retirement Association; and

5.17 (9) the judges' retirement plan.

5.18 (c) The commissioner of management and budget must determine the amount of the  
5.19 allocation under paragraph (a) for each pension plan specified in paragraph (b). Each  
5.20 allocation is directly appropriated to the pension fund for each pension plan by the  
5.21 commissioner. The commissioner must report the amounts appropriated under this section  
5.22 to the chairs and ranking minority members of the house of representatives Ways and Means  
5.23 Committee and the senate Finance Committee by August 15, 2022.
