2.15 felony punishable by not more than five years imprisonment or a fine of not more than

5.2 Notwithstanding the requirements of this act or Laws 2023, chapter 12, a completed
 5.3 voter registration application submitted by a voter is not deficient for purposes of registering
 5.4 that voter if the application form was printed or provided to the voter prior to the effective
 5.5 date of any modification required by this act or by Laws 2023, chapter 12. Beginning on
 5.6 the effective date of a modification required by this act or by Laws 2023, chapter 12, an
 5.7 election official must not print, copy, or publicly distribute a blank voter registration
 5.8 application that does not include the required modification.

5.9 **EFFECTIVE DATE.** This section is effective the day following final enactment."
