1.15 Subd. 1a. **Transmittal of fees to commissioner of management and budget.** (a) Every
1.16 person, including the state of Minnesota and all bodies politic and corporate, who shall
1.17 transact any business in the district court, shall pay to the court administrator of said court
1.18 the sundry fees prescribed in subdivision 2. Except as provided in paragraph (d), the court
1.19 administrator shall transmit the fees monthly to the commissioner of management and budget
1.20 for deposit in the state treasury and credit to the general fund. ~~\$30~~ \$60 of each fee collected
1.21 in a dissolution action under subdivision 2, clause (1), must be deposited by the commissioner
1.22 of management and budget in the special revenue fund and is appropriated to the

2.1 commissioner of employment and economic development for the Minnesota Family
2.2 Resiliency Partnership under section 116L.96.

2.3 (b) In a county which has a screener-collector position, fees paid by a county pursuant
2.4 to this subdivision shall be transmitted monthly to the county treasurer, who shall apply the
2.5 fees first to reimburse the county for the amount of the salary paid for the screener-collector
2.6 position. The balance of the fees collected shall then be forwarded to the commissioner of
2.7 management and budget for deposit in the state treasury and credited to the general fund.
2.8 In a county in a judicial district under section 480.181, subdivision 1, paragraph (b), which
2.9 has a screener-collector position, the fees paid by a county shall be transmitted monthly to
2.10 the commissioner of management and budget for deposit in the state treasury and credited
2.11 to the general fund. A screener-collector position for purposes of this paragraph is an
2.12 employee whose function is to increase the collection of fines and to review the incomes
2.13 of potential clients of the public defender, in order to verify eligibility for that service.

2.32 clause (13), must be transmitted to the county treasurer for deposit in the county general

3.2 used by the county to pay for child support enforcement efforts by county attorneys.
