1.4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.5	Section 1. TIMELINE FOR ENDING RESTRICTIONS ON BUSINESSES DURING
1.6	THE COVID-19 PANDEMIC.
1.7	Subdivision 1. Executive orders. Notwithstanding any conflicting provisions of an
1.8	executive order to the contrary, this section governs the operation of private businesses in
1.9	the state, as of the dates indicated. At all times and until repealed by law or rescinded by
1.10	the governor, all provisions of an executive order not in conflict with these guidelines
1.11	continue to apply.
1.12	Subd. 2. The day after final enactment. The day after final enactment of this section:
1.13	(1) bars and restaurants may operate at 75 percent capacity for both indoor and outdoor
1.14	dining, as long as parties are separated by six feet of distance. Parties are limited to ten
1.15	people for table seating, two people for bar seating. Food and beverage service must stop
1.16	by 10:00 p.m. each night;
1.17	(2) indoor and outdoor events, including weddings, may be held with attendance limited
1.18	to 50 percent of the capacity of the space, as long as parties from different households are
1.19	separated by six feet of distance. Total attendance may not exceed 100 people and events
1.20	must end by 10:00 p.m.;
1.21	(3) even when telework is feasible, it is no longer mandatory; and

2.4	Subd. 3. 30 days after final enactment. 30 days after final enactment of this section:
2.5	(1) bars and restaurants may operate normally;
2.6	(2) indoor and outdoor events, including weddings, may be held with attendance limited
2.7	to 75 percent of the capacity of the space. Total attendance may not exceed 250 people and
2.8	events must end by midnight;
2.9	(3) hair salons may operate at 75 percent capacity;
2.10	(4) movie theaters may operate at 75 percent capacity; and

2.12	Subd. 4. 60 days after final enactment. 60 days after final enactment of this section

2.14	Subd. 5. Alteration of timeline. A body composed of the governor and the leaders of
2.15	the majority and largest minority parties of the house and the senate may at any time vote
2.16	to delay or advance the timeline established under this section. Alteration of the timeline
2.17	requires the agreement of four of the five members of this body.
2.18	EFFECTIVE DATE. This section is effective the day after final enactment.
