1.4 Subd. 17. **Reusable water bottles or cups.** Notwithstanding any law to the contrary, a
1.5 licensed child care center may provide drinking water to a child in a reusable water bottle
1.6 or reusable cup if the center develops and ensures implementation of a written policy that
1.7 at a minimum includes the following procedures:

1.8 (1) each day the water bottle or cup is used, the child care center cleans and sanitizes
1.9 the water bottle or cup using procedures that comply with the Food Code under Minnesota
1.10 Rules, chapter 4626, or allows the child's parent or legal guardian to bring the water bottle
1.11 or cup home;

1.12 (2) a water bottle or cup is assigned to a specific child and labeled with the child's first
1.13 and last name;

1.14 (3) water bottles and cups are stored in a manner that reduces the risk of a child using
1.15 the wrong water bottle or cup; and

1.16 (4) a water bottle or cup is used only for water."

1.21 ~~door to the residence. The door to the residence may be~~ (a) If there is an opening between
1.22 an attached garage and a day care residence, there must be a door that is:

- 2.1 (1) a solid wood bonded-core door at least 1-3/8 inches thick;
- 2.2 (2) a steel insulated door if the door is at least 1-3/8 inches thick; or
- 2.3 (3) a door with a fire protection rating of 20 minutes.

- 2.5 of gypsum wallboard or its equivalent that is 1/2 inch thick."

- 2.14 Page 9, line 26, after "the" insert "applicant or"
- 2.15 Page 14, line 24, strike "and"
- 2.16 Page 14, line 27, strike the period and insert "; and"
- 2.17 Page 14, after line 27, insert:
- 2.18 "(5) at the time of the incident, the individual was performing duties identified in the
- 2.19 licensed center's child care program plan required under Minnesota Rules, part 9503.0045.
- 2.20 This clause applies only to child care centers licensed under Minnesota Rules, chapter 9503."

- 2.23 Amend the title accordingly
