Bill Description

This bill clarifies the Council establishment of transit fare programs for all modes including Bus, LRT, and Commuter Rail.

Transit passes. The council may establish transit fare programs and passes; that are consistent with the fare policy purposes stated in subdivision 2, including but not limited to:

- (1) discount pass programs for public and private employers, public and private organizations, and school districts; and
- (2) special pass programs for demonstration projects or special events.

REPEALER. Minnesota Statutes 2022, section 473.408, subdivisions 6, 7, 8, and 9, are repealed. The Fare Policy Items repealed are Monthly Passes, Employee Discount Passes, Charitable Organization Discount Passes and Youth Discount Passes all for regular route bus service. The bill clarification will include Bus, LRT and Commuter Rail for all these items.

Sec. 3. EFFECTIVE DATE; APPLICATION. This act is effective the day following final enactment and applies in the counties of ¿ Anoka, Carver, Dakota, Hennepin, Ramsey, Scott, and Washington.

<u>Assumptions</u>

This bill clarifies the Council establishment of transit fare programs for all modes including Bus, LRT, and Commuter Rail. It is permissive, but does not prescribe any additional programs or additions to the current pass programs. It has no impacts on fare revenues or expenses.

Expenditure and/or Revenue Formula

This bill only provides clarification language and has no impacts on fare revenues or expenses.
