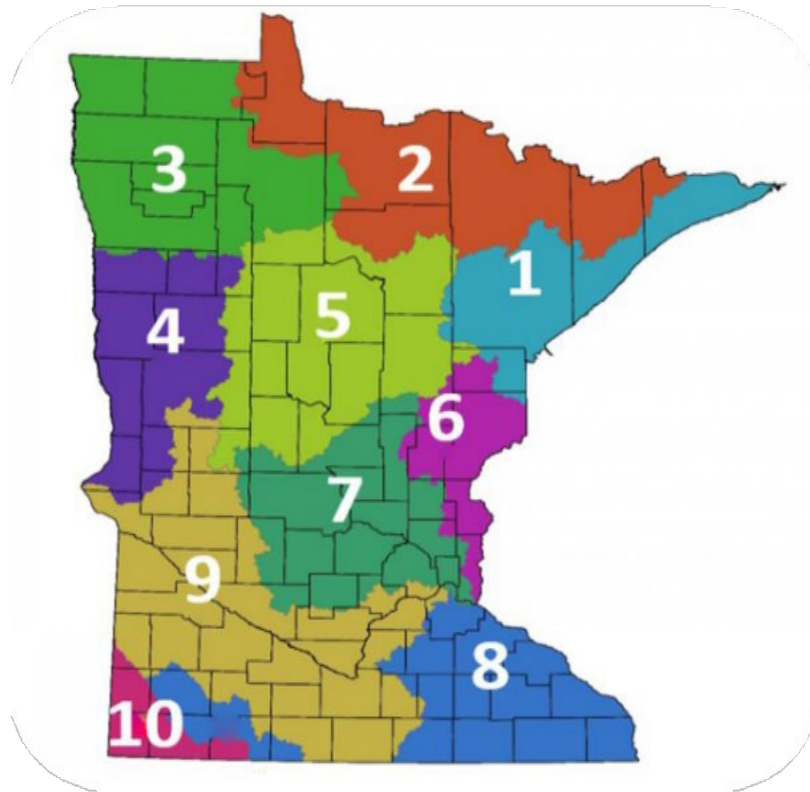
- Larger, higher-quality wetland mitigation

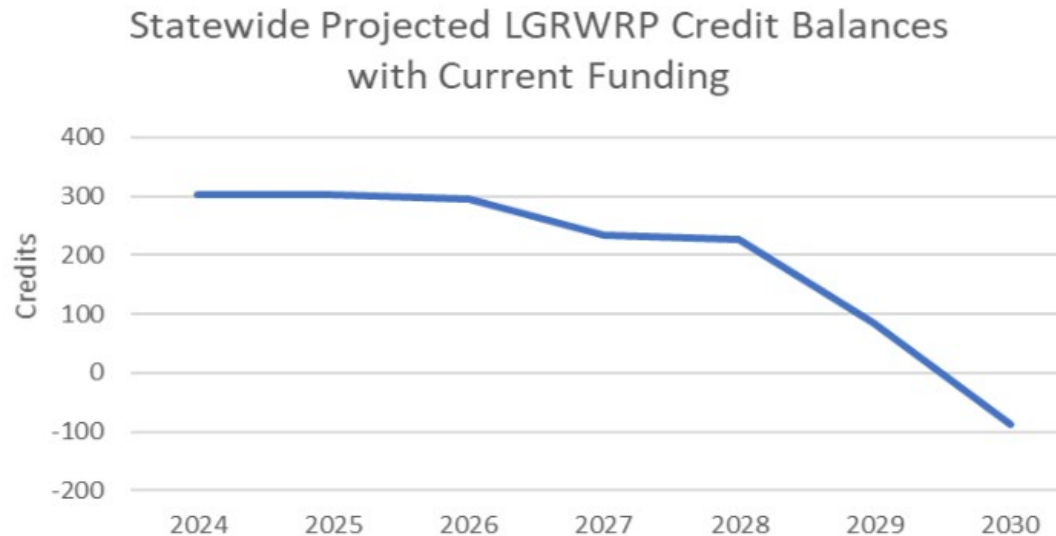

Wetland Credit Projections

- Eight to ten years from appropriation to final credit release



- Funding must be based on credit needs three to ten years into the future

Conservation Reserve Enhancement Program (MN CREP)

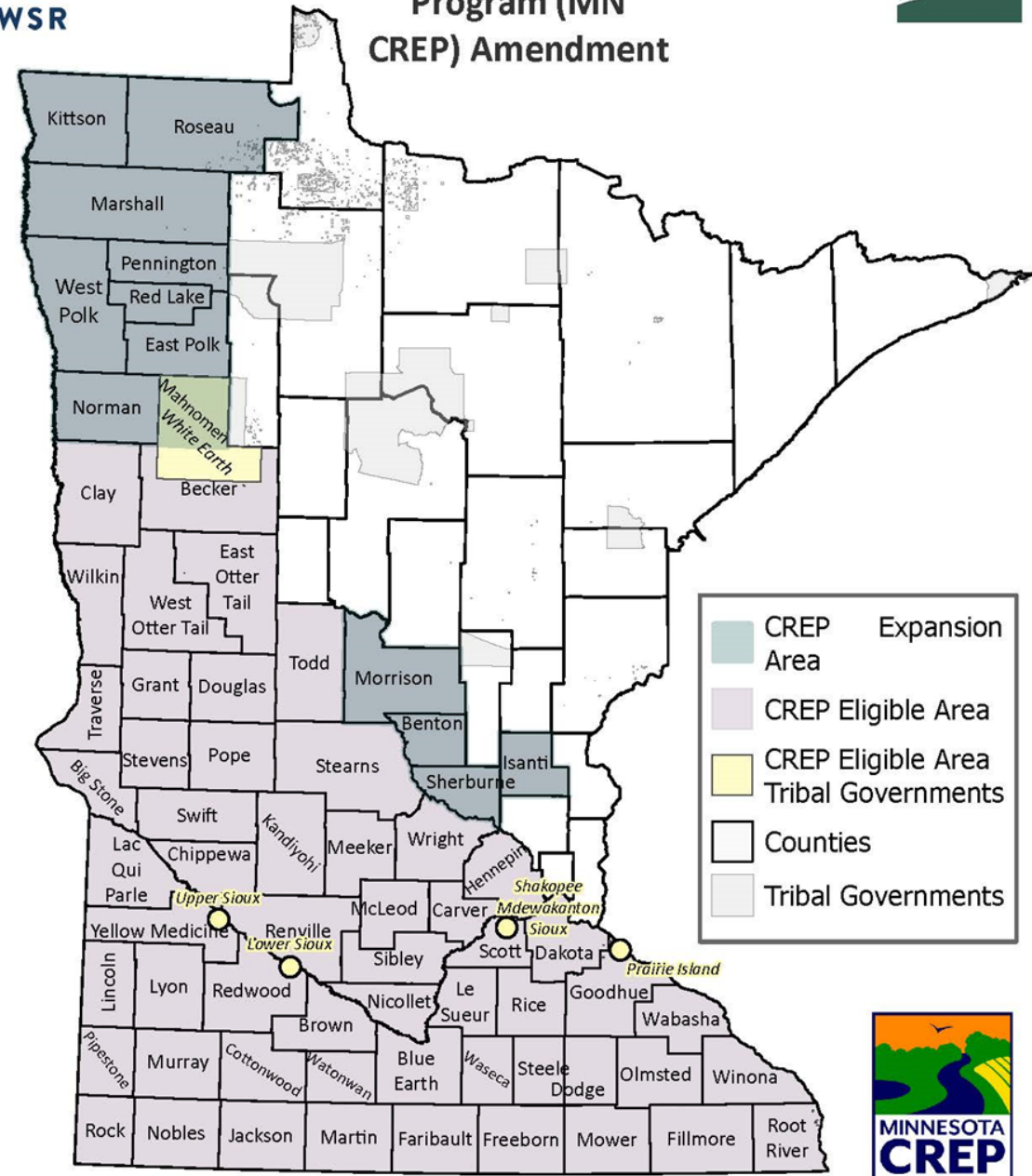


- State-held easements
- Targeted environmentally sensitive lands
 - buffers
 - wetlands
 - wellhead protection for drinking water
 - carbon sequestration

MN CREP

Agreement amended/extended
January 2025

- adds 12 new counties
- increases acreage cap from 60,000 to 75,000
- Adds private well protection practices
- Fed:State funding leverage 70:30
