

1.1 ..... moves to amend H.F. No. 3581 as follows:

1.2 Page 10, after line 17, insert:

1.3 "Sec. .... **EMERGENCY CRIME PREVENTION; APPROPRIATION.**

1.4 Subdivision 1. **Appropriation.** \$16,400,000 in fiscal year 2023 is appropriated from  
1.5 the general fund to the commissioner of public safety for grants to crime prevention programs  
1.6 for the purpose of providing public safety to victims. This is a onetime appropriation. As  
1.7 used in the section "crime prevention programs" includes but is not limited to:

- 1.8 (1) re-entry programs;
- 1.9 (2) victim services programs;
- 1.10 (3) homelessness assistance programs;
- 1.11 (4) mental health and social service programs;
- 1.12 (5) restorative justice programs;
- 1.13 (6) co-responder programs;
- 1.14 (7) juvenile diversion programs; and
- 1.15 (8) community violence interruption programs.

1.16 Subd. 2. **Application for grants.** (a) A crime prevention program may apply to the  
1.17 commissioner of public safety for a grant for any of the purposes described in subdivision  
1.18 1 or for any other emergency assistance purpose approved by the commissioner. The  
1.19 application must be on forms and pursuant to procedures developed by the commissioner.  
1.20 The application must describe the type or types of intended emergency assistance, estimate  
1.21 the amount of money required, and include any other information deemed necessary by the  
1.22 commissioner.

2.1 (b) Any crime prevention program that applies for a grant for the purpose described in  
2.2 subdivision 1 may not spend more than half of the full grant on law enforcement expenses.  
2.3 The application must estimate the amount of money required for reimbursement costs,  
2.4 estimate the amount of money required for administrative costs, and include any other  
2.5 information deemed necessary by the commissioner. An applicant may not spend in any  
2.6 fiscal year more than five percent of the grant awarded for administrative costs.

2.7 Subd. 3. **Reporting by crime prevention programs required.** A crime prevention  
2.8 program that receives a grant under this section shall file an annual report with the  
2.9 commissioner of public safety itemizing the expenditures made during the preceding year,  
2.10 the purpose of those expenditures, and the ultimate disposition, if any, of each case. The  
2.11 report must be on forms and pursuant to procedures developed by the commissioner.

2.12 Subd. 4. **Report to legislature.** By February 1, 2023, the commissioner of public safety  
2.13 shall report to the chairs and ranking members of the senate and house of representatives  
2.14 committees and divisions having jurisdiction over criminal justice policy and finance on  
2.15 the implementation, use, and administration of the grant programs created under this section."
