#### The Board licenses or registers over 26,000 individuals and facilities annually.

## About Us (Continued)

#### • Programs under the Board of Pharmacy:

- Medication Repository Program
  - The Board contracted with a vendor to run a central repository which accepts donations of useable drugs from nursing homes, pharmacies, wholesalers, and manufacturers. Medications are then dispensed to individuals who cannot afford them.
- Insulin Safety Net Program
  - Insulin manufacturers are required to operate urgent and continuing need programs. Insulin is provided at low cost to individuals who meet certain criteria.
- Insulin Manufacturer Registration Fee Program
  - Insulin manufacturers not qualifying for an exemption are subject to a \$100,000 fee which is deposited in the insulin safety net program account.

## About Us (Continued)


#### • Programs under the Board of Pharmacy (continued):

- Opiate Product Registration Fee Program (OPRFP)
  - All opiates distributed in or into the State of MN must be reported to the Board. Manufacturers with 2 million or more opiate units distributed in a year must pay a \$250,000 fee. Fees are deposited into the Opiate Epidemic Response fund to further disperse as the State addresses the opioid epidemic.
- Minnesota Prescription Monitoring Program (PMP)
  - All dispensed controlled substance prescriptions are reported to the PMP which is then used as a clinical tool for prescribers and pharmacists when providing patient care.
  - The PMP is intended to aid in clinical decision making and minimize prescription drug abuse.


### **Change Item Requests**

- Extend availability of previously appropriated funds for ongoing legal costs
  - Request does NOT involve additional funding
- Increase Board's FY26 and FY27 spending authority
  - Critical to preserve current staffing and operation amid rising costs
  - Maintain service level of the Prescription Monitoring Program (PMP)

## **PMP** Utilization




#### Since receiving integrated access...
