2.6 "Sec. 9. **APPRAISER INTERNET COURSE REQUIREMENTS.**

2.7 Notwithstanding Minnesota Statutes, sections 45.305, subdivision 1a and 45.306,
2.8 subdivision 1a, education providers may submit to the commissioner of commerce for
2.9 approval a classroom course under Minnesota Statutes, section 45.2, subdivision 2a, clause
2.10 (3), or a distance learning course, as defined in Minnesota Statutes, section 45.25, subdivision
2.11 5a, that has not been approved by the International Distance Education Certification Center.

2.12 **EFFECTIVE DATE.** This section is effective the day following final enactment and
