I serve as City Administrator for the City of Becker and President of the Coalition of Utility Cities. I

write to express the City of Becker's support for House File 1750, which would call for the creation

of a state transition plan for communities and workers that will be impacted by major power plant

retirements, while also creating an infrastructure within DEED to help carry out that plan.



As this committee is aware, Becker is home to Xcel Energy's Sherburne County Generating Station, also known as "Sherco." Sherco is Xcel's largest coal plant in Minnesota, but all three of the coal-fired units at the plant have been scheduled or proposed by for retirement by 2030. The plant makes up 75% of our tax base while providing hundreds of high-quality, family-sustaining jobs that


Again, thank you for your consideration of this legislation, and we ask you to see it through to final passage this year.

Thank you for your consideration of HF 1750 which would provide the essential transition support for communities facing imminent power plant retirements. Minnesota is shifting towards a cleaner energy solution, but the transition will greatly impact local jobs, the economy and the tax base.

As you know, every large investor-owned power plant is already scheduled for early retirement or will be considered for retirement within the next 20-years. This is true for Minnesota Power's Boswell energy plant located in the city of Cohasset in Itasca County. The Boswell power plant provides some of the best paying jobs in Itasca County; jobs that simply cannot be readily found in other industries within our County. In addition, Boswell is the primary power source for major infrastructure clients who provide crucial national security resources as well as global trading commodities. Lastly, Boswell contributes highly to our tax base and, plainly stated, transition time is needed to allow communities to adjust and plan for this revenue void.

The creation of the Minnesota Energy Transition Legacy Office would provide the vehicle to assist our local communities the time and expertise needed to assist in the progression process. The new Office will evaluate the impact of power plant retirements, address the concerns regarding lost employment and tax base while providing recommendations to mitigate the impacts to local governments and workers.

Itasca County is in support of HF 1750 and appreciates your assistance in passage of the bill.
