1.13 project approved by the voters, plus an amount to be applied to the payment of the costs of
1.14 issuing the bonds. The bonds may be paid from or secured by any funds available to the
1.15 political subdivision, including the tax authorized under this section and approved by the
1.16 voters. The issuance of bonds under this subdivision is not subject to sections 275.60 and
1.17 275.61.

1.18 (b) A separate election to approve the bonds under section 475.58 is not required."
