Although my legal practice primarily involves other areas of law (those areas are described on the enclosed resume), I have relevant professional and volunteer experience. For example, I have argued election-related cases at the Minnesota Court of Appeals, Minnesota Supreme Court, and North Dakota Supreme Court; I have represented a number of clients in election law matters at the Minnesota Office of Administrative Hearings; and I have volunteered in various capacities for political and community organizations at all levels—including parties, campaigns, and committees. Through these experiences, I have gained a practical perspective on issues confronting the Board on a regular basis.

My previous volunteer activities also reflect my interest in community service, consistent with a role on the Board. I currently serve as Chair of the Board of Community Action Partnership of Hennepin County, a board with more than twenty members from diverse backgrounds, where I have been an active board member since 2009. I was appointed to serve on the state Compensation Council, and selected to participate in the Humphrey Policy Fellows Program.
