PROGRAM HIGHLIGHTS



More than 200 portfolios submitted for licensure have been approved from Fiscal Year 2023.

19,000+ supported 19,956 teachers or teacher candidates were supported with funding from the Student Teaching Stipend Pilot Program, the CUGMEC Grant, the TMRG, and the Alternative Pathways to Licensure funding.



From the inaugural cohort of the Heritage Language Educator Pathway, 88% of portfolios already submitted for review have been approved, with more currently under review or being revised.






