As co-Chair of the effort to secure funding for expansion of the Keystone Food Shelf, I am writing to request your support for inclusion of Keystone Community Services in any state finance proposal and their funding request for \$3 million dollars for the rehabilitation of a new facility located near Allianz Field in Ramsey County. We fully support their plan to rehabilitate and repurpose a building along University Avenue to expand their food shelf and community services.

Residents of Ramsey County are in great need of the increase in the capacity of Keystone Community Services at their proposed new location. The plan for a larger community food shelf, warehouse and community center will provide a one stop shop for the neighborhood to receive critical services in a location that meets them where they live and work.
