13.13 of providing public transit, whether or not the vehicle is owned or operated by a public
13.14 entity.

13.15 (d) "Public transit facilities" or "transit facilities" means any vehicles, equipment,
13.16 property, structures, stations, improvements, plants, parking or other facilities, or rights that
13.17 are owned, leased, held, or used for the purpose of providing public transit, whether or not
13.18 the facility is owned or operated by a public entity.

13.19 (e) "Fare medium" means a ticket, smart card, pass, coupon, token, transfer, or other
13.20 medium sold or distributed by a public transit provider, or its authorized agents, for use in
13.21 gaining entry to or use of the public transit facilities or vehicles of the provider.

13.22 (f) "Proof of fare payment" means a fare medium valid for the place or time at, or the
13.23 manner in, which it is used. If using a reduced-fare medium, proof of fare payment also
13.24 includes proper identification demonstrating a person's eligibility for the reduced fare. If
13.25 using a fare medium issued solely for the use of a particular individual, proof of fare payment
13.26 also includes an identification document bearing a photographic likeness of the individual
13.27 and demonstrating that the individual is the person to whom the fare medium is issued.

13.28 (g) "Authorized transit representative" means the person authorized by the transit provider
13.29 to operate the transit vehicle, a peace officer, a transit official under section 473.4075,
13.30 subdivision 1, or any other person designated by the transit provider as an authorized transit
13.31 representative under this section.
