► The 2025 legislative session got off to a delayed start after House Democrats boycotted the first 23 days, while still collecting taxpayer-funded paychecks. Their refusal to show up forced a special session and left Minnesotans footing the bill. But with an evenly split House, Republicans got to work cleaning up the mess of the last two years – when Democrats blew an \$18 billion surplus, raised taxes by \$10 billion, and drove the state into a record \$6 billion deficit.

This year, with the end of the Democrat trifecta, House Republicans focused on six core priorities: **Stop the Fraud, Make Minnesota Affordable, Make Minnesota Safe, Raise Standards, Reduce Mandates, Minnesota Tax Dollars for Minnesotans, and Build for the Future.**

## STOP THE FRAUD
