## Overview

This bill contains various local liquor provisions for additional licenses and licenses for establishments that could not be licensed under general law.

## Section

 Minneapolis licenses. Authorizes Minneapolis to issue intoxicating liquor licenses to the Historic Pantages Theatre and the American Swedish Institute. Authorizes Minneapolis to issue wine/beer licenses to the Jungle Theater, the Guthrie Lab, and the Southern Theatre.
Blaine licenses. Authorizes Blaine to issue 15 on-sale intoxicating liquor licenses in addition to the number authorized by law.
Elko Speedway license. Authorizes Elko to issue an on-sale intoxicating liquor license to the Elko Speedway notwithstanding statutory requirements that a licensed premises be compact and contiguous, as long as the premises are within the fenced grandstand area.

- 4 Hastings licenses. Authorizes Hastings to issue 3 on-sale intoxicating liquor licenses in addition to the number authorized by law.
- 5 **Maple Grove licenses.** Authorizes Maple Grove to issue 12 on-sale intoxicating liquor licenses in addition to the number authorized by law.
- **6 Sartell licenses.** Authorizes Sartell to issue 5 on-sale intoxicating liquor licenses in addition to the number authorized by law.
- 7 St. Michael licenses. Authorizes St. Michael to issue 5 on-sale intoxicating liquor licenses in addition to the number authorized by law.
- 8 State fair wine licenses. Allows St. Paul to issue on-sale wine licenses to concessionaires at the state fair for sale of Minnesota-produced wine in connection with the sale of food.
- **9 Waconia licenses.** Authorizes Waconia to issue 3 on-sale intoxicating liquor licenses in addition to the number authorized by law.
- **10 Woodbury licenses.** Authorizes Woodbury to issue 12 on-sale intoxicating liquor licenses in addition to the number authorized by law.
- **11 Effective date.** Makes all sections effective immediately.
