Overview

This bill changes the administration and distribution of need-based and state-funded financial aid programs to assist postsecondary students with the cost of attending postsecondary institutions, assist with child care costs, and provide aid through work-study programs. Under current law, all state appropriations for financial aid are made to the Higher Education Services Office (HESO) and allocated to participating, eligible institutions for grants to eligible students.

This bill makes the governing boards of the two public postsecondary systems - the University of Minnesota and the Minnesota State Colleges and Universities (MnSCU) - responsible for administering financial aid for their campuses and students, and the Private College Council responsible for financial aid for their member institutions and students. HESO continues to receive pass-through appropriations for the Private College Council and receives appropriations and retains direct administrative responsibility for financial aid for students attending other private postsecondary institutions. For the public systems, appropriations are made for each program to the responsible governing board.

Authorizes HESO to make grants to the Minnesota Private College Council to administer all types of state-funded financial aid for their members, including child care grants, work-study and need-based financial aid. - **2 to 6** Eligible institution. Limits HESO's direct administration of state-funded financial aid programs to private postsecondary institutions that are not members of the Private College Council.

Authorizes the MnSCU Board of Trustees to administer state appropriations for all types of state-funded financial aid for their members, including child care grants, work-study and need-based financial aid.
