Overview

This bill makes technical corrections to health and human services appropriations and policy provisions that were included in the 2013 health and human services omnibus finance bill.

Section

- 1 **Common entry point designation.** Amends § 626.557, subd. 9. Delays the effective date of the common entry point for reporting suspected maltreatment of vulnerable adults from July 1, 2014, to July 1, 2015.
- 2 Transfer. Amends Laws 2013, ch. 1, § 6, as amended by Laws 2013, ch. 108, art. 6, § 32. Modifies the way in which the commissioner of management and budget must calculate certain transfers from the health care access fund to the general fund for specified MA costs for fiscal years 2014 to 2017. Makes this section effective retroactively from July 1, 2013.
- **3 Grant programs.** Amends Laws 2013, ch. 108, art. 14, § 2, subd. 6. Makes technical corrections to human services grant program appropriations for fiscal years 2014 and 2015. Makes this section effective retroactively from July 1, 2013.
- **4 Total appropriation.** Amends Laws 2013, ch. 108, art. 14, § 3, subd. 1. Makes technical corrections to health department appropriations for fiscal years 2014 and 2015. Makes this section effective retroactively from July 1, 2013.
- 5 Health improvement. Amends Laws 2013, ch. 108, art. 14, § 3, subd. 2. Makes technical corrections to health improvement program appropriations for fiscal years 2014 and 2015. Makes this section effective retroactively from July 1, 2013.

- 6 Health protection. Amends Laws 2013, ch. 108, art. 14, § 3, subd. 4. Makes technical corrections to health protection appropriations for fiscal years 2014 and 2015. Makes this section effective retroactively from July 1, 2013.
- Board of Nursing Home Administrators. Amends Laws 2013, ch. 108, art. 14, § 4, subd.
 8. Makes technical corrections to Board of Nursing Home Administrators appropriations for fiscal years 2014 and 2014. Makes this section effective retroactively from July 1, 2013.
- 8 Appropriation adjustments. Amends Laws 2013, ch. 108, art. 14, § 12. Modifies the way in which the commissioner of management and budget must calculate certain adjustments to the appropriation from the health care access fund for specified MA costs for fiscal years 2014 to 2017. Makes this section effective retroactively from July 1, 2013.
