Overview

This bill includes provisions related to the sale, exchange, and conveyance of land and other provisions related to the administration of land by the Department of Natural Resources (DNR).

Section

- 1 Lake Vermilion-Soudan Underground Mine State Park, St. Louis County.** Amends § 85.012, subd. 38a. Renames the “Soudan Underground Mine State Park” the “Lake-Vermilion-Soudan Underground Mine State Park” (the Vermilion and Soudan Underground Mine state parks are combined under section 38 of this bill).
- 2 Disposal of tillable land in Memorial Hardwood Forest.** Amends § 89.022. Modifies the exemption from sale/exchange requirements that apply to tillable land acquired in the Richard J. Dorer Memorial Hardwood Forest by allowing the county board (rather than the Legislative-Citizen Commission on Minnesota Resources (LCCMR) as provided under current law) approve exemptions and allows the exemptions when the land has been or will be acquired for natural resource and public access purposes. States that revenues received under the section are to be deposited in the natural resources fund (rather than the general fund as required under current law).
- 3 Nonconservation lands; appraisal and sale.** Amends § 282.01, subd. 3. Removes a requirement that the commissioner of natural resources approve timber appraisals and tax-forfeited land sales for nonconservation lands with standing timber on them. Removes special notification requirements of counties with state forests within them.

Section

- 4** **Classification, sale, procedures and conditions.** Amends § 282.011, subd. 1. Removes a requirement of counties to submit a list of certain tax forfeited lands to the DNR for approval of their classification.
- 5** **Land on or adjacent to public waters.** Amends § 282.018, subd. 1. No longer requires the DNR to approve the sale of tax-forfeited lands bordering public water with 150 feet or less of waterfront. Removes a requirement that the DNR evaluate tax-forfeited lands bordering water that have been withdrawn from sale and make recommendations to the legislature on the disposition of the lands.
- 6** **List of lands for sale; notice.** Amends § 282.02. Technical.
- 7** **Accept donations.** Amends § 459.06, subd. 1. Removes a requirement that the DNR approve a local government's selection of lands and management plans for memorial forests.
- 8** **Withdrawal of tax-forfeited lands.** Amends § 459.06, subd. 3. Allows tax-forfeited land within a memorial forest to be withdrawn from the forest and disposed of as tax-forfeited land without DNR approval.
- 9** **Lake-Vermilion-Soudan Underground Mine State Park; annual payments.** Amends § 477A.17. Modifies payment-in-lieu of tax (PILT) payments applicable to lands within Lake Vermilion and Soudan Underground Mine state parks to reflect the merger of the two parks under this bill, clarify that the payments apply to state-owned lands within the park, and modify the process used to appraise the lands so that it is the same as the process used for other acquired natural resources lands subject to PILT.
- 10** **Deletions from state recreation area.** Removes land from the Greenleaf Lake State Recreation Area.
- 11** **Addition to state forest.** Adds land to the Snake River State Forest.
- 12** **Brainerd Dam; city of Brainerd.** Provides authorization for the city of Brainerd to purchase the Brainerd Dam. Under current law, a government entity may not purchase or otherwise take ownership of a dam until the DNR examines the dam, submits a report to the legislature on the dam, and the legislature has had an opportunity to review the situation and hasn't prohibited it.
- 13 to 37** **Sale, conveyance, or exchange of lands.** Permits the public sale, private sale, conveyance, and exchange of certain state and tax-forfeited lands in locations as described in the bill, including parcels contained in this bill as introduced and the following bills:

- 38** **Merger of Soudan Underground Mine State Park, St. Louis County, into Lake Vermilion State Park, St. Louis County.** States that Soudan Underground Mine and Vermilion state parks and merged into one park to be known as Lake Vermilion-Soudan Underground Mine State Park.
- 39** **Revisor’s instructions.** Requires the Revisor to combine the legislative histories of Soudan Underground Mine and Vermilion state parks which are merged into one park under the previous section. Requires the Revisor to recodify a section of statute currently in chapter 84 pertaining to the exchange of certain lands into a new section in chapter 94.
- 40** **Repealer.** Repeals § 85.012, subd. 53a (Soudan Underground Mine State Park).
- 41** **Effective date.** Provides an effective date the day following final enactment for all sections in the bill.
