## **Section**

- **1 Expedited license processing; military.** Requires occupational licensing boards listed in Minnesota Statutes, section 214.01, subdivisions 2 and 3 to establish a procedure to expedite issuance of licenses to active duty military members and theirs spouses and to veterans who have left service in the past two years.
- 2 **Report on temporary licenses.** Requires the governor to designate representatives of professional licensing boards to report to the legislature by January 15, 2015 on procedures for issuing temporary licenses to active duty military members and theirs spouses and to veterans who have left service in the past two years. Specifies topics to be covered in this report and conditions that the recommendations must follow.

### Subd. 2. Health-related licensing board.

"Health-related licensing board" means the Board of Examiners of Nursing Home Administrators established pursuant to section 144A.19, the Office of Unlicensed Complementary and Alternative Health Care Practice established pursuant to section 146A.02, the Board of Medical Practice created pursuant to section 147.01, the Board of Nursing created pursuant to section 148.181, the Board of Chiropractic Examiners established pursuant to section 148.02, the Board of Optometry established pursuant to section 148.52, the Board of Physical Therapy established pursuant to section 148.67, the Board of Psychology established pursuant to section 148.62, the Board of Marriage and Family Therapy pursuant to section 148.81, the Board of Behavioral Health and Therapy established by section 148.51, the Board of Dietetics and Nutrition Practice established under section 148.622, the Board of Dentistry established pursuant to section 150A.02, the Board of Pharmacy established pursuant to section 151.02, the Board of Podiatric Medicine established pursuant to section 153.02, and the Board of Veterinary Medicine established pursuant to section 156.01.

#### Subd. 3.Non-health-related licensing board.

"Non-health-related licensing board" means the Board of Teaching established pursuant to section <u>122A.07</u>, the Board of Barber Examiners established pursuant to section <u>154.001</u>, the Board of Cosmetologist Examiners established pursuant to section <u>155A.20</u>, the Board of Assessors established pursuant to section <u>270.41</u>, the Board of Architecture, Engineering, Land Surveying, Landscape Architecture, Geoscience, and Interior Design established pursuant to section <u>326.04</u>, the Private Detective and Protective Agent Licensing Board established pursuant to section <u>326.33</u>, the Board of Accountancy established pursuant to section <u>326A.02</u>, and the Peace Officer Standards and Training Board established pursuant to section <u>626.841</u>.
