Overview

This is the annual omnibus liquor bill.

Section

- **Bulk distilled spirits.** [Hoppe] This provision adds a definition of bulk distilled spirits.
- **Bulk wine.** [Hoppe] This provision adds a definition of bulk wine.
- Microdistilleries. [Hoppe] Allows microdistilleries to self-distribute to retailers or wholesalers. Allows operation of a "cocktail" room. Places conditions on operation of a cocktail room, including local licensure. Requires these rooms to be a distinct license.
- 4 **Microdistilleries.** [Hoppe] Technical to conform with section 3.
- 5 Small brewer license. [Swedzinski] Allows growler sales on Sundays by small brewers.
- **6 Interest in other business.** [Committee] Allows growler sales on Sundays by brewpubs.
- **Sales.** [Hoppe] Increases production limits for farm wineries from 50,000 gallons per year to 65,000 gallons.
- **Storage.** [Hoppe] Allows storage of farm winery products in a noncontiguous warehouse. Conforms this provision with existing rules already adopted by the Department of Public Safety. Requires notice of location to DPS.
- **Bulk wine or distilled spirits.** [Hoppe] Provides that if no wholesaler is able to provide these spirits in bulk form, a farm winery may purchase them on the open market.

Section

- Sacramental wine. [Lien] This provision restores the sacramental wine sales allowed prior to 1995, via religious book or supply stores. The language has been tightened, including a limited insurance requirement for stores with larger sales, and tighter description of allowed sales.
- **Special provision; city of Minneapolis.** [Clark] Allows on-sale licenses for the Swedish American Institute and the Minneapolis Institute of Arts.
- Wine licenses. [Hoppe] Removes a food service requirement for service of wine and beer. Increases the allowed percentage of alcohol in wine to 24 percent.
- License revocation or suspension; civil penalty. [Committee] Adds failure to comply with establishment operation requirements as an enforceable aspect of license revocation.
- Mixed drinks or cocktails. [Hoppe] Allows storage of cocktails that are mixed, or infused liquors. Specifies limits on amount and duration of storage.
- **Malt liquor samples authorized.** [Hoppe] Allows up to 12 sampling events per year, for brewers, up from current level of five.
- **City of Richfield; on-sale license.** [Slocum] Allows an on-sale license for professional hockey events at the Richfield Ice Arena.
- **Special license; Golden Valley.** [Winkler] Allows Golden Valley to issue an on-sale license to a city-owned golf course.
- **Brooklyn Park.** [Hortman] Allows an on-sale license to a wedding event center in Brooklyn Park.
- **Special closing times; 2014 All-Star Game.** [Atkins] Allows special closing times for two days connected to the 2014 all-star game, with local approval and issuance of license.
- **Revisor's instructions.** [Committee] Requires the revisor to re-codify brewer and brewpub statutes for clarity purposes.
