### Overview

This bill modifies practice supervision requirements for licensing psychologists, licensed professional clinical counselors, marriage and family therapists, and social workers, to allow all hours of supervised practice to be fulfilled through telesupervision.

| 1 | <p><b>Supervisory consultation for an applicant for licensure as a licensed psychologist.</b></p> <p>Amends § 148.925, subd. 5. Specifies that supervision consultations for psychology licensing applicants may be provided through telesupervision and requires the board to allow applicants to satisfy postdegree supervised psychological employment requirements entirely via telesupervision.</p> <p>Provides an immediate effective date.</p> |
| 2 | <p><b>Supervision requirement; postgraduate experience.</b></p> <p>Amends § 148B.33 by adding subd. 1a. Requires the Board of Marriage and Family Therapy to allow applicants to satisfy supervised postgraduate experience requirements entirely with supervision provided via real-time, two-way interactive audio and visual communication.</p> <p>Provides an immediate effective date.</p>   |
| 3 | <p><b>Supervision.</b></p> <p>Amends § 148B.5301, subd. 2. Requires the Board of Behavioral Health and Therapy to allow licensed professional clinical counselor applicants to satisfy supervised professional practice requirements entirely with supervision received via real-time, two-way interactive audio and visual communication.</p>  |

Modifies graduate social worker supervision requirements; requires the Board of Social Work to allow licensed graduate social workers who do not engage in clinical practice to satisfy supervision requirements entirely with supervision received via eye-to-eye electronic media, while maintaining visual contact.</p> <p>Provides an immediate effective date.</p>
6	<p><b>Types of supervision.</b></p> <p>Amends § 148E.106, subd. 3. Modifies graduate social worker supervision requirements; requires the Board of Social Work to allow licensed graduate social workers engaged in clinical practice to satisfy supervision requirements entirely with supervision received via eye-to-eye electronic media, while maintaining visual contact.</p> <p>Provides an immediate effective date.</p>
7	<p><b>Supervision; clinical social work practice after licensure as licensed independent social worker.</b></p> <p>Amends § 148E.110, subd. 7. Modifies licensed independent social worker supervision requirements; requires the Board of Social Work to allow licensed independent social workers engaged in clinical practice to satisfy supervision requirements entirely with supervision received via eye-to-eye electronic media, while maintaining visual contact.</p> <p>Provides an immediate effective date.</p>
