2011 and 2012 LGA under Current Law, and HF 130 Vs under HF. 42, the second engrossment

The attached run shows the certified 2011 LGA and estimated 2012 LGA under current law, 2011 LGA under H.F. 130 (conference committee report), and under H.F. 42, the second engrossment (H.F. 42-2). This is the same as the proposal under the H042A19 amendment.

H.F. 130 provided that each city would get the lesser of (1) its certified 2011 LGA or (2) its paid 2010 LGA amount

Under the proposed alternative under HF42, the second engrossment (shown in columns 3 and 6) Aid payments for cities would be as follows:

In Pay 2011

- 1st class cities as of 2008 would receive 75% of the aid under H.F. 130
- Remaining cities would receive the same aid as under current law

In Pay 2012

- 1st class cities as of 2008 would receive 50% of the aid under H.F. 130
- Remaining cities would receive the same aid as under H.F. 130

- **Column 1:** Certified 2011 LGA
- **Column 2:** H.F. 130 LGA in 2011
- **Column 3:** 2011 LGA under H.F. 42, the second engrossment
- **Column 4:** Loss in 2011 LGA under H.F. 42-2 compared to certified 2011LGA
- **Column 5:** Estimated 2012 LGA under current law
- **Column 6:** 2012 LGA reduction under H.F. 42, the second engrossment
- **Column 7:** Loss in 2012 LGA under H.F. 42-2 compared to current law 2012 LGA
