

Certified* 2020 LGA vs. estimated 2021 LGA under current law

Summary

The attached run shows the distribution of the 2020 LGA after corrections for a tax base data error, and estimated 2021 LGA under current law.

The statutory appropriation for 2020 LGA is \$560,398,012 however \$561,353,137 will actually be paid to cities in CY 2020. The tax base for 3 cities – Minneapolis, St. Paul, and South St. Paul, where mistakenly understated when CY 2020 aid was calculated. This resulted in aid increases to those 3 cities being too high and lower aid increases to other cities. The statute requires that the aid for all the cities that had lower certified aids be corrected and the extra paid out of the general fund without lowering payments to other cities (Minn. Stat. §477A.014, subd. 2 and 3). The corrected 2020 aid calculation for all cities is used as the starting point for calculating their 2021 LGA amounts

The new permanent appropriation amount beginning with aids payable in 2021 is almost equal to the amount appropriated for city LGA in CY 2002 – the year with the highest appropriation for this program.
