

## **2009 LGA under Minnesota Laws 2008, Chapter 366 vs. old law**

The attached run shows certified 2008 LGA; projected 2009 LGA under the old law, including changes including in Laws 2008 Chapter 154, and projected 2009 LGA under the new law included in Laws 2008, chapter 366. Chapter 366 contains an LGA appropriation increase of \$42 million for aids payable in 2009, an additional 2 percent increase in Pay 2010, and another 4 percent increase in Pay 2011.

Changes from old law include:

- ▶ The small city portion of the current city aid base equal to \$6 per capita is eliminated and replaced with a new, separate small aid base of \$8.50 per capita. The \$8.40 is increased if the LGA appropriation increases.
- ▶ Regional center aid is retained but 36 percent of it is used to reduce a city's new city jobs based aid, up to a maximum reduction of \$1.0 million.
- ▶ A new city jobs based aid is established for cities with a population over 5,000. City jobs base aid is equal to \$25.20 per capita multiplied by population and by the ratio of employees to population in the city. No city's job based aid can exceed \$4.725 million. The \$25.20 is increased annually based on the IPD.
- ▶ Data used in calculating the Pay 2009 formula aid is based on the factors used to calculate Pay 2008 LGA.
- ▶ Formula aid is now equal to small city aid plus city job base aid plus a percentage of the difference between city revenue need and ability to pay. Formula aid cannot be less than zero.
- ▶ The maximum LGA increase in Pay 2009 for any city is increased to 35 percent of the previous year's levy.
- ▶ No large city's aid may go down by more than \$300,000, 10 percent of its previous year's levy, or \$10 per capita, whichever is less.
- ▶ No small city's aid may go down by more than \$10 per capita or 5% of its certified 2003 aid, whichever is less.
- ▶ The appropriation is increased by \$40 million plus an amount equal to the city aid bases increases listed in the next bullet.
- ▶ The following permanent city aid base increase is granted - \$100,000 annually to Browns Valley. The following temporary city aid base increases are granted - \$100,000 for five years to Crookston, \$25,000 for ten years to Mendota, and a one time \$90,000 to Spring Lake Park in Pay 2009.
- ▶ Beginning in Pay 2010 the city formula aid uses the average of 2 years of "unmet need" (city need – ability to pay under current law) , based on data known as of January 1 in year in which aid is certified.
